15. Multidisciplinary / interdisciplinary

NEP-2020 have been implemented in the college from the session 2022-23. As per NEP-2020, "multidisciplinary education aims to develop social, physical, intellectual, emotional, and moral capacities of human beings in an integrated manner. A flexible curriculum as per NEP-2020 will facilitate creative combinations of various disciplines. Learners can choose from languages and at the same time fields such as Applied Sciences, Mathematics, and Business Studies. This aims at developing critical thinking, versatility, adaptability, problem solving, flexibility, and analytical and communication skills in the learners. The opportunities of doing research are enhanced and improved through a holistic and multidisciplinary approach. The holistic and multidisciplinary education is likely to benefit in employment. It improves the ability to approach problems with a broader perspective and prepares students for new jobs in emerging fields." The college is prepared to provide more holistic understanding of the world to students under NEP and for that it has already adhered to the interdisciplinary/multidisciplinary approach as per the curriculum provided by the University of Jammu under CBCS and NEP-2020. Through this approach the college provides diverse knowledge to students. The college provides 27 skill courses to students in addition to the core courses, giving them choice in the fields of study of academic interests. In addition to this, Value Added Courses (VAC) under NEP-2020 are taught (Digital

Technologies, Understanding India, Health and wellness and Environmental science and Education. Ability enhancement courses: - Modern Indian Languages, English and Communication English. Multidisciplinary Foundation Courses, Major and Minor courses in different disciplines. Science, arts and humanities, social and behavioural science, commerce, management and BCA courses. Moreover, extension lectures across varied disciplines are arranged from time to time in order to provide and boost the multidisciplinary/interdisciplinary culture in the college.

16.Academic bank of credits (ABC):

The college has implemented NEP-2020 from the session 2022-23. One of the provisions of the NEP 2020 is the introduction of the ABC. ABC is a virtual storehouse that is a centralised repository housing the comprehensive credit records of individual students as they progress through their educational journey. This system empowers students to access their accounts seamlessly and offers sufficient choices when it comes to transitioning between different colleges or universities. ABC that allows students of undergraduate and postgraduate degree courses to exit the course and enter within a stipulated period. ABC ID's of all students of the college has been created.

17. Skill development:

As reported by Ministry of Education, Govt. of India, "India is going to have the largest working age population in the world by 2030, but gainful employment for students from the general stream is a major challenge. Improving the employability of students requires a new vision with curricular support." The NEP-2020 has advocated for the integration of vocational education programmes into mainstream education in all education institutions, in a phased manner. NEP-2020 further envisions that vocational courses will be available to students enrolled in all Bachelor's degree programmes, including the four-year multidisciplinary Bachelor's programmes. NEP-2020 has been implemented in the college from the session 2022-23. Skill enhancement courses in 27 subjects are taught in the college. Institutions Innovation Council has been established in the college. The college has Innovation and Incubation Cell. Essential Skill Development and the Constitution of India are mandatory courses, which are compulsory for all students to get constitutional and citizenship values. Values and Ethics course is made mandatory for all to have ethical values inculcated. Different social programs are organized and various NSS activities are organized by student chapters and clubs to imbibe the holistic human values needed for the overall character development of an individual. Yoga training camps are also organized for all students to assimilate the values needed to live a peaceful life. In order to safeguard the future and help in the overall development of an individual, the college has a well established Skill Development/Empowerment Cell. The skill programme focuses on providing employment opportunities to students, which can contribute to the growth of the Indian Economy.

18. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The NEP 2020 aims to reconfigure the education system of India on the framework of Indian Knowledge system with its emphasis on the rebuilding of Indian Languages, Arts and Culture. The NEP 2020 recognizes India's rich and eternal knowledge history, which includes Jnan, Vignan, and Jeevan Darshan as its guiding principles, with evolution based on experience and experiments. The Indian Knowledge Systems (IKS) is recommended to be scientifically integrated including tribal knowledge and indigenous & traditional modes of learning. It intends to encompass topics such as mathematics, astronomy, philosophy, yoga, architecture, medicine, agriculture, and so on. Though English is accepted as the main medium of instruction in the college for many subjects, yet the faculty members makes use of many other languages including Urdu and Hindi vet in order to make students understand the subject matter. Taking into consideration that the language plays a key role in inculcating social, moral and ethical values and transferring culture to the next generation, the college has well equipped language lab to stimulate the sense of preserving the rich Indian culture through language among the students. In order to promote the local language, art and culture, NSS conducted activities in adopted village in local languages. Moreover, as the students of the college are belonging to various groups/tribes--like Gujjar, Bakarwal, Pahari, Kashmiri etc., all are therefore given chance to perform their own cultural activities in their own traditional language, dress code in various events organized by the college. Our college magazine and the wall magazines are also published in multi languages namely English, Urdu and Hindi where the students can published their write-ups in their own languages. As most of our students are from rural areas, so they are given freedom to share their thoughts and ideas in their own language.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The college has been providing Outcome-Based Education (OBE) through choice-based credit system for about six years and has implemented NEP-2020 from session (2022-23). The focus of this approach is that students should attain measurable knowledge, skill and attitude when they complete the program or study. The basic understanding of the concepts coupled with the clear goals and knowing what they would like to study and how they would like to study, is of prime and utmost priority of the college. Since, the college is affiliated to the University of Jammu and the curriculum is designed by it with the help of suggestions taken from the college faculty, during Board of Studies meetings, in which due care is taken of learning outcomes. The curriculum is prepared with course outcome. In the college, every department prepares the list of learning outcomes (PO and Cos). This is student centred approach that helps them to engage more with the curriculum. The college keeps list of these outcomes available on the website for all stakeholders.

20. Distance education/online education:

Although the college offers maximum courses in regular mode but also facilitates the learning of students through distance/online mode. Three distance education centres have been established in the college by MoU with IGNOU, MANUU and University of Jammu which caters to need of large number of students especially those who are employed or those who cannot afford to undertake their studies in regular mode. The Indira Gandhi National Open University study centre offers number of UG & PG courses in Arts and commerce in distance mode. The Maulana Aazd National Urdu University study centre also offers number of UG & PG courses in Arts in distance mode. Moreover, the distance education centre of Jammu University offers number of UG programmes in arts and commerce streams. At present more than 1000 students are enrolled in IGNOU, MANUU & Jammu University centres. Although the college does not offer any online programme but the faculty is using online mode of teaching via different platforms including MOODLE LMS, google meet, zoom and wise app. Some of the faculty members also use Youtube for delivering pre-recorded lectures through online mode. The students are directed to do MOOCS courses. It is mandatory for PG students to earn minimum of two credits through MOOCS for completion of their degrees.
